# JVCKENWOOD Recognized on CDP's Climate Change A List for the First Time

Yokohama, December 22, 2025—JVCKENWOOD Corporation has been recognized for the first time on CDP's Climate Change A List, the highest rating in the 2025 climate change assessment conducted by CDP, a global non-profit organization operating an international environmental disclosure system.



#### **Inclusion on the CDP A List**

CDP operates a global environmental disclosure system that is widely recognized as the international standard for corporate environmental reporting. The data is widely used by investors and procurement organizations to inform decision-making. In 2025, more than 22,100 companies worldwide disclosed environmental information through the system.

CDP evaluates companies on an eight-level scale ranging from D- to A. JVCKENWOOD has received an A score, the highest possible rating. Companies awarded an A score are recognized as global leaders for their proactive approach to addressing environmental risks and for taking initiative in implementing advanced climate actions, earning inclusion on CDP's Climate Change A List. In the previous 2024 assessment cycle, only approximately the top 2% of all companies evaluated worldwide were included on the Climate Change A List.

#### **JVCKENWOOD's Environmental Initiatives**

Under its corporate philosophy of "Creating excitement and peace of mind for the people of the world," JVCKENWOOD promotes sustainability management based on two pillars: profitable growth and solving social issues on a global scale. Based on the sustainability strategy under its medium-term management plan, VISION 2025, the Company has established its environmental policy, "JK Green 2030," and has positioned addressing climate change as one of its key sustainability priorities. Toward the realization of carbon neutrality by 2050, JVCKENWOOD has set targets to reduce greenhouse gas (GHG) emissions associated with its business activities and is managing progress toward those targets.

The Company also places emphasis on transparent disclosure of environmental information, and continues to provide comprehensive disclosures, including the disclosure of climate-related risks and opportunities in line with the recommendations of the Task Force on Climate-related Financial Disclosures (TCFD), as well as reporting of Scope 1, Scope 2, and Scope 3 emissions.

In the current year's survey, initiatives such as the promotion of its climate transition plan, increased use of renewable energy in business activities, and the strengthening of its governance framework were evaluated, leading to this selection.

Looking ahead, JVCKENWOOD will continue to disclose a wide range of environmental information through the website, the integrated report, and other channels, while advancing initiatives to achieve targets and contributing to a sustainable society through business activities.
