New Management Structure Coming into Force After This Year's Ordinary General Meeting of Shareholders and Appointment of Executive Officers and Organizational Changes Effective April 1, 2020

At its Board of Directors meeting today, JVCKENWOOD Corporation (JVCKENWOOD) decided on the nomination of nine candidates for Directors, three candidates for Audit & Supervisory Board Members, and one candidate for substitute Audit & Supervisory Board Member whose appointment will be submitted for approval at the 12th Ordinary General Meeting of Shareholders scheduled for late June of this year, as well as the appointment of Executive Officers and Organizational Changes effective April 1, 2020, as outlined below.

1. Procedure of Determining New Management Structure and Executive Officers

JVCKENWOOD has established a voluntary Nomination and Remuneration Advisory Committee (the "Committee"), which proposes the Representatives candidates to the Board of Directors; receives advice from the Representatives candidates on the candidates for Directors, Audit & Supervisory Board Members and Executive Officers, examines the appropriateness of such advice and reports its opinions to the Board of Directors. The Board of Directors determines the Representatives, candidates for Directors and Audit & Supervisory Board Members; appoints Executive Officers; and determines compensation of Directors, Audit & Supervisory Board Members, and Executive Officers, taking into consideration the opinions stated by the Committee.

In conformity to the above-mentioned procedure, JVCKENWOOD adopted at its Board of Directors meeting held today a resolution for the new management structure coming into force after this year's Ordinary General Meeting of Shareholders and the appointment of Executive Officers and organizational changes effective April 1, 2020 upon receiving a proposal from the Committee in the meeting.

2. New Management Structure Taking Effect After This Year's Ordinary General Meeting of Shareholders
