## ■ Outline of ISO/IEC 27001:2013 and JIS Q 27001:2014

ISO/IEC 27001:2013 specifies international standards for information security management systems that provide for requirements to establish and implement the framework to protect information assets, and was formulated for companies to handle information they own, including personal information, properly and safely. The subject of protection under these standards is not limited to personal information but also includes confidential information owned by companies.

JIS Q 27001:2014 is Japanese industrial standards created based on international standards ISO/IEC 27001:2013 covering the same technical requirements and compositions.
