Notice Regarding Change of Representative Directors of the Board and New Management Structure

At its Board of Directors Meeting held today, JVCKENWOOD Corporation ("JVCKENWOOD") decided upon the candidates for nine Directors, three Audit & Supervisory Board Members and one substitute Audit & Supervisory Board Member for election at the 8th General Meeting of Shareholders scheduled to be held in late June this year. In addition, the new Executive Officer structure to be approved at the Board of Directors Meeting to be held after the General Meeting of Shareholders was also decided. There will be also changes to the Representative Directors of the Board as follows.

The changes will be officially decided at the 8th General Meeting of Shareholders and the Board of Directors Meeting to be held thereafter.

1. Reasons for changes of Representative Directors of the Board and launch of new management structure

In the fiscal year ended March 2012, JVCKENWOOD achieved a successful turnaround and began dividend payment after overcoming fateful crises such as the Lehman Brothers collapse and the financial crisis in 2008 and a massive negative legacy it has faced since its establishment in October 2008. Also, there has been a sudden deterioration in its operating results accelerated by the weaker yen as well as the rise of smartphones. In response, JVCKENWOOD has been implementing structural reforms on a global basis while focusing on shifting from consumer businesses to professional businesses with the aim of recovering its business performance. Owing to such efforts, the Company has resumed dividend payment for the previous fiscal year. Over the course of implementing such reforms, JVCKENWOOD has launched company-wide development task forces and has been engaged in business development including the digital cockpit system for automobiles while also carrying out M&As of overseas companies to promote growth strategy.

In May 2015, JVCKENWOOD announced "Vision 2020," a new mid- to long-term business plan. This time, the Company has decided to launch a new management structure of the next generation with the aim of realizing the visions specified under the business plan by promoting new growth.
